#### **Eyewitness Evidence**

The American criminal justice system depends heavily on eyewitnesses to determine the facts surrounding criminal events. Eyewitnesses are asked to remember sightings, recreate situations, identify culprits, and provide other details pertaining to the crime; these accounts are presented to the jurors, who are civilians randomly chosen to provide a verdict. The evidence that eyewitnesses provide, especially if the eyewitnesses have no motive to lie and seem confident in their accounts, has the capacity to strongly influence the jurors. In the case that there is no definitive proof, eyewitness accounts alone may serve as primary proof for the crime.

- However, the advent of DNA testing in the late 20th century has brought the legitimacy of eyewitness evidence to question. DNA analysis of past cases since 1992 revealed that a vast majority of eyewitnesses give mistaken information and fail to correctly identify the culprit approximately 50% of the time. This is a problem because it leads the jurors to convict an innocent person as guilty. Many factors contribute to eyewitnesses' mistaken information, but one is personal bias. For example, research shows
- 15 that if a person of a respectable reputation, substantial influence, high socioeconomic status, and clean background confidently accuses an innocent person of a crime, it is very likely that the person will be convicted guilty by the jurors. This leads us to the question: what can be thought of as an alternative to human eyewitnesses, who have been proven by data to be fallible?

One possible answer to this question is to implement robot analogs to act as communicators between eyewitnesses and jurors so that personal bias can be eliminated. Human beings inherently trust other human beings' opinions more than those given by nonhumans or numerical data alone. This is backed up by the following psychological study: psychologists held two mock trials, one with human eyewitnesses, and the other with

- 25 robotic analogs instead of humans. Human eyewitnesses were told to purposely supply the wrong information. The robots, on the other hand, were programmed to be factually perfect. They told only correct information and were not prone to personal bias. The subjects in the psychological study were asked to take on the role as jurors who did not know whether the humans or robots were speaking the truth. Psychological scientists studied whether the humans appealing untruthfully or the robots.
- 30 humans speaking untruthfully or the robots speaking truthfully were considered more reliable by the jurors. The results showed that human beings are more comfortable listening to other human beings than non-human beings.

This study illustrates the myriad obstacles that exist around faulty human testimonies. However, while the use of robotic analog intermediaries between eyewitnesses and juries may help to reduce bias, there is considerable opposition to the proposal in both the lay and legal communities and therefore no changes to the current practice are likely to be implemented in the near future.
